I wanted to personally respond to the letter that we received this afternoon. First of all I want to thank you for your support during some trying times. We are finally coming to a point where the negative matters that we have been dealing with for a long time will finally be behind us. The dealings with our ex-CEO and SEC have been a millstone around our necks that will soon be in the past. The good news is that our partners and customers have not only stuck with us, but have continued to support our efforts. Mother Parkers has agreed to convert 1.75 million of moneys owed into a three year note. I will be finalizing that on June 13. As far as the royalty's due, our investors have agreed to using proceeds to get us fully paid up to date, pay the SEC and give us working capital so we will be on solid ground moving forward. We could try and make a substantial payment of the royalty in the next couple of weeks if needed.

I am excited about the future and hopefully you are to. Myself and our whole team of dedicated people have worked tirelessly to keep the company moving forward and we will continue to work hard to make everyone proud of Marley Coffee.
